Letter from the Interim Rector

Dear People of St. David's,

The story of 2020 is overshadowed by the Covid Pandemic. We started the year, with great hope. I had been with you since August, and I was at the point of really knowing most of the regular attendees. Arrangements had been made for my accommodation at the home of Sandy and Paul Szymanski, and I was learning my way around this part of the state. We celebrated Epiphany season and had entered into the season of Lent. Then everything came to a halt. The Bishop issued an order to cease in-person worship, and even to avoid spending time in the office. That Sunday, there was no common worship at St. David's, but some very resourceful parishioners joined me to work out on-line worship. We took a subscription to GoToMeeting, which seemed to be the easiest platform to manage, and we notified members that we could gather to pray together at 9:00 each Sunday, with the idea that parishioners could then participate in the on-line services with the Bishop from Trinity Cathedral or from the National Cathedral. The Lenten study, which had already begun, had to be abandoned, since there was no way to show a video on GoToMeeting. An unofficial Tech Team was created, with Todd White, Brian Katona, Allie Graham and Ben Hicks. They began researching alternatives, and they came up with Zoom. With their guidance, we made a new start into the on-line world of worship. I commented that this presented problems for which my seminary training had not prepared me. Now that I was a televangelist, I didn't know where to park my private jet.

The internet went wild with conversations about on-line worship. Our Bishop started his on-line services using the Eucharist Service from the Prayer Book. He fasted from communion, in solidarity with the people worshiping with him from at home, but that meant that the consecrated elements were simply disposed of rather than consumed. I was in agreement that if communion was not available to those participating on-line, then I should also not have communion. I reached into the scriptures and history of the Church to find that it was common for early Christians to celebrate what they called Agape feasts. These were gatherings centered around a shared meal, with the focus that it was the remembrance of Jesus that brought them together. So with Brian's assistance in providing resources for music, I developed a service that had the elements of our usual Liturgy of the Word, combined with prayers and remembrances for the needs of the world, and culminating in sharing some food together. It also had to be real, in expressing our sense of loss for what we really wanted—to be back in our sanctuary, singing and praying together, and taking the Body and Blood of Christ.

At the same time, there was some anticipation that, with appropriate cautions, we might be able to have in-person worship in our sanctuary, once it seemed the virus was diminishing. Deanna Emerson, Pat and Larry Kraft, Deacon Hank Bristol and Kathy Herzog worked as a team created in response to the Bishop's Re-opening Committee to create that safe environment and equip us with the materials and guidelines for St. David's. The Tech Team put together a plan for live-streaming worship from the church and gathered the necessary equipment. We created an on-line registration method to maintain a safe number of people in the building. In-church worship began again in August. We had a Thursday evening Adult Study of some of the big issues in modern day Christianity. We maintained our Sunday worship from the sanctuary until news of an upsurge once again created a more serious condition, and we reverted to Zoom only. Allie Graham has begun her studies at Princeton Theological, working toward ordination. She has joined Hank and me in the preaching rotation. Kate O'Connor regularly leads the Spiritual Communion Prayer on-line.

Advent was celebrated on-line, and a study of some of the Parables of Jesus was conducted on-line. This is where we stand today. Christmas was celebrated with an outdoor Service, created by Hank Bristol and the Children's Ministry team. It threatened to rain, but that held off and we struggled with high winds, but it was sweet to hear children's voices read the Nativity Story. The later Service and Christmas Day Service were back on Zoom. The Christmas Season was rounded out by a Christmas Lessons and Carols worship presided over by Hank, with Brian and the St. David's virtual choir providing music.

Innovation this year has been primarily directed toward our Zoom worship, and we have, in my opinion, grown to present a fairly polished service. One addition this year, made easier on Zoom, was a display of Christmas Creche figures in people's homes. I had introduced that in my last church assignment, and they were eager to tell me that they had kept it going this year. The ornament exchange at the beginning of Advent could not be done this year, but I hope these two ideas will become cherished traditions at St. David's. The Chrismon tree in the parish hall also could not be put up this year.

Kim Duck, who was coordinator for Children's ministries, got together with the teachers to maintain an ongoing program for our littlest ones on Saturday mornings. They went so far as to create craft kits which they distributed. Likewise, they made Easter and St. Nicholas Day special. Kim has stepped down as leader, and Deacon Hank has stepped up to coordinate this ministry.

Deacon Hank has led book studies during the pandemic. Kate O'Connor began an on-line Contemplative Prayer group. She has also begun a telephone ministry so our solitary parishioners, particularly those without internet service, may be contacted. The 9:15 am Healing Service has been conducted all year on-line, with a lively discussion following.

Brother John Baptist has not been very visible this year. I touch base with him occasionally. His age and frailty prevent him from going out very much, but he doesn't complain. He visits a close friend at the Elms. Another dear member we have not seen much this year is our Deacon Candidate Carol Rodgers. She began her pastoral year at Trinity Church in Moorestown and then continued on to Holy Trinity Church in South River. Carol was present Christmas Eve for the Family Service, and it was good to be able to bump elbows.

This year we were able to lay to rest some members whose funerals were delayed by the closure of the church, Angela Holman, Carol Henning, Peter Turner and Dorothy Poklitar. May they rest in peace and rise in glory.

The worship at St. David's depends on our Sunday bulletins, which are the work of our Parish Administrator, Judy Henningsen, who has held down the office this year. She manages communication and is still Clerk of the Vestry– meetings on-line. I can't begin to tell you how many ways she has been vital to me in keeping things going.

For me, one of the best innovations has been the way we bless each other. Even on-line, people join in the birthday and anniversary blessings by raising their hands. All of the Body of Christ have the ability and the responsibility for bringing blessing to the world.

The Epiphany Season brings with it some reason for hope. Several vaccines against the epidemic have been approved for use. It will be months before we are able to see the effects of those vaccines, but we know that time is coming. Soon Lent will be upon us. Last year, Ash Wednesday came before the pandemic church closures. We will have to give serious thought to how we can enter into Lent this year. To that end, within the next few weeks I will call a very informal meeting of anyone interested as we prepare to celebrate Ash Wednesday and the season of Lent. Prayer and worship are the work of the people.

I am also extremely grateful to Deanna Emerson, our Senior Warden, and Ed Miller, our Junior Warden. I am also grateful to John Patterson, who took over the role of Treasurer (because this is definitely not my gift).

Minutes of the Annual Meeting 2020

The meeting was called to order on Sunday, January 26, 2020 at 11:54 am with an opening prayer by the Interim Rector, the Rev. Donald R. Caron (DRC+). DRC+ opened the polls stating that this vestry will be the vestry voting for the new rector and it will be a great opportunity to be involved with the vestry.

Chris Achen, speaking for the Nominating Committee, gave the report of the committee and introduced the nominees and asked them to stand: Sr. Warden, Deanna Emerson, and Vestry 3-year terms: Janet Boyle, Jon Harding, and Scott Holcombe. For Diocesan Convention Delegates: David Miller, Steve Channon, Elizabeth Channon, with Deanna Emerson and Ed Miller as Alternates. Nominations from the floor were requested. Chris Achen thanked the nominees for their willingness to serve.

Greetings from the Interim Rector

Father Don (DRC+) welcomed and thanked everyone for attending the 2020 Annual Meeting. DRC+ continued his greeting by thanking everyone again for the warm welcome he has received, and he is very pleased to be called to be your Interim Rector. He continues to implement new ideas for during the service.

Adoption of minutes from 2019 Annual Meeting held on Jan. 20, 2019

A motion was made by Steve Channon and seconded by Ed Miller to dispense with the reading of the minutes. All were in favor and the motion was carried.

A motion to approve the minutes as presented was made by John Patterson and seconded by Ed Miller. The minutes were then adopted by voice vote. All were in favor and the motion was carried.

Reports

Treasurer's Report – Tim Doutt, by Title

Tim Doutt started his presentation by highlighting a few items from Statement of Assets & Liabilities page of his report which is on page 15 of the Annual Report.

Tim Doutt thanked the Finance Committee, David Thomsson, Deanna Emerson, John Patterson, Amy Mansue, Tena Achen and the dedicated counters who prepare the deposit each Sunday.

Tim continued his report stating St. David's is 12 years ahead of schedule for paying off the mortgage. Tim also asked everyone to read the important financial reports on pages 26-27 which relate to stewardship, the endowment fund, and the Legacy Society.

Tim reviewed the balance sheet and stated this is a preliminary statement of assets and liabilities as year-end adjustments will be made from the 2019 audit. Tim continued discussing the audit process and asked if any would like to see the audit report or has any questions regarding the audit to please see or email him.

Tim thanked Tena Achen and the Stewardship Committee for their efforts with the 2020 Stewardship Drive.

Tim continued his report by reviewing several lines of the budget which is located on page 16 & 17 of the Annual Report. This budget supports the works of several committees including the Safety Committee. Also transition expenses, personnel costs, and other ongoing projects. Tim also stated this budget has our full 2020 Fair Share Diocesan pledge in it. The budget was approved at the January 14, 2020 vestry meeting.

DRC+ requested a motion from the floor to accept the Treasurer's Report. A motion was made by Ed Miller and seconded by Scott Holcombe to accept the Treasurer's Report. After a voice vote, all were in favor and the motion carried.

DRC+ also stated the Legacy Society is important and urged everyone to include St. David's in their will. DRC+ also stated that investments that require a mandatory distribution at 70 ½ years of age can be given to the church directly tax-free and is worth looking into.

Deacon Report – by Title with thanks and discussed the vestry retreat workshop lead by Canon Droste. Deacon Hank encouraged everyone as we are moving forward to participate in new ministries.

Kim Duck handed out and then discussed the St. David's Emergency Operation Plan and Emergency Procedure Guide to the congregation. Kim asked everyone to take home and read. Kim continued stating the ushers will have a different view on how they approach their job each Sunday. There will be a primary usher of the day. Kim discussed that this document will be reviewed each year to make sure that it stays current and that each group that uses the building is familiar with it. Kim discussed the wish list of safety committee. i.e. AED Training, updating locks & windows, adding cameras, first aid kits, etc.) Kim concluded by thanking Richard Bailey and ushers and will start to implement these changes shortly.

Clara reported the committee is in the process of setting of the parish profile. She asked everyone to return the survey, which was sent out by mail and email ASAP so they can bring to the vestry for approval.

DRC+ requested a motion to accept the Annual Reports. A motion was made by Steve Channon and seconded by David Miller to accept all reports as presented. After a voice vote, all were in favor and the motion carried.

Vestry Appreciation – Deanna Emerson thanked Chris Achen for serving 6 years on the vestry and presented him with a gift. Deanna also thanked Deacon Hank for his teaching and for leading the bible study at the vestry meetings.

Closing of Polls

Chris Achen announced that hearing no nominations from the floor, the polls were closed at 12:52 pm. A motion was made by Ed Miller and seconded by John Patterson to accept the Vestry and the Convention/Convocation Delegates slate as presented. After a voice vote, all were in favor and the motion carried.

Open Time

DRC+ stated the vestry commissioning will be held at the 10 am service on Sunday, Feb. 2 and the vestry retreat will be held on Saturday, Feb. 8th.

Sandy Szymanski thanked Deanna Emerson and asked everyone to applaud her hard work during the transition. David Miller also asked everyone to also thank Judy Henningsen. Deanna Emerson stated her job is made easier with such a great church.

The meeting was adjourned with a motion by Pat Kraft and seconded by Laura Labassi at 1:00 p.m. After a voice vote, all were in favor and the motion carried.

Father Don lead the benediction, and all were dismissed.

Report of the Treasurer

2020 was a year of significant events in the financial life of St. David's. Probably the most notable change was the retirement of Tim Doutt as our Treasurer after sixteen years in that position. Tim and Amy have moved to northern Pennsylvania to be closer to their family and as a result Tim has left us both as Treasurer and Sexton.

Prior to Tim's departure, we were able to finalize the outcome of the 2018 audit. This resulted in restatement of several entries on the balance sheet. The revised balance sheet is shown on page 16 and the explanations of the changes are found on page 17.

The 2020 CARES Act included the Paycheck Protection Program (PPP) which provided forgivable loans to small businesses and non-profit organizations. These loans were designed to replace lost income resulting from the coronavirus pandemic. St. David's submitted an application to First Constitution Bank of Cranbury and was awarded a PPP loan of \$22,558. We have recently been notified that this loan has been completely forgiven.

In view of the expected increase in expenses related to the hiring of a new rector, we began investigating the refinance of our outstanding mortgage. When the pandemic occurred, it became apparent that we would need any reduction of expenses which we could achieve. After reviewing several offers to refinance the mortgage, we accepted the offer from the Diocese of New Jersey Ventures in Mission (VIM) Fund for an unsecured twenty-year loan at an interest rate of 4.0%. The previous loan has an interest rate of 6.75% and about 7 ½ years left. This refinance has reduced our monthly mortgage payment by about \$3,700/month; however, it has added many years to the payment schedule.

Several changes in the Balance Sheet between 2019 and 2020 are apparent (page 18). The new mortgage is reflected in the Liabilities section. At the end of 2019, the balance on the ECBF 2014 Loan was \$344,291. The remaining balance was completely paid off with the proceeds of the VIM 2020 Loan which had a \$317,502 balance at the end of 2020. The other change in the Balance Sheet is the combination of the two reserve funds. Funds from the 1st Const – Ready Reserve account were moved to the TRP Government MM account and the 1st Const – Ready Reserve account was closed.

2020 has progressed very differently from the budget (see pages 19-21) mainly due to the changes in our operations brought on by the pandemic. Our inability to use the building for most activities for most of the year substantially impacted our income by reducing our Building Use and Fundraising Income. In addition, due to an overly optimistic estimate, our Non-Pledge Income is substantially below budget. However, due to the generosity of our parishioners, the Spring Challenge resulted in over \$32,000 of unbudgeted income. On the expense side, several expenses were below budget due to the curtailed activities. Both Building Maintenance and Utilities were below budget because of low usage of the building. The budgeted Capital expenses have not occurred because of inability to have the work done and lack of the funds. Clergy Compensation was below budget due to substantially reduced travel expenses. Lay Compensation was below budget due to the lack of a Sexton since Tim's departure. Our reopening expense (COVID-19) was not budgeted and has been substantial. All in all, the year ended with a \$26,767 surplus which includes the \$22,558 PPP Grant.

The 2021 budget (pages 19-21), which was approved by the vestry, continues the history of strong support of activities within our church and active outreach to outside organizations. The budget assumes that we will install a new rector at the end of the first quarter of 2021. The budget also assumes that we will be able to use the church building in the middle of the year. At that time, the assumption is that in-person services will resume and building use income will resume. In addition, we have assumed that fundraising activities will resume in the fall of 2021.

The 2020 Fund Summary (on page 22) is a report which shows the activity within the restricted funds which exist at St. David's. The final balance of each fund is shown on the Balance Sheet. This report shows the activity in each of those accounts.

I could not perform this position without lots of help. First, I would like to thank Tim for the training he gave me and the clear records he provided. I would like to thank the Finance Committee composed of David Thomsson, Chair, Tena Achen, Deanna Emerson, Ed Miller and Fr. Don. The Stewardship Committee lead by Tena Achen was able to complete a pledge drive which almost equaled the 2019 results during an exceedingly difficult year. Special thanks go to Judy Henningsen who was called upon this year to perform all the weekly counts and data entry of parishioners' contributions.

At the end of 2020, St. David's is in a strong financial position. The main checking account balance is \$58,178 of which \$50,969 are unrestricted funds available for the operation of the church. In addition, the TRP Government MM account contains \$38,815 which are reserve funds available for operations. St. David's has been blessed to have a very generous congregation in 2020.

2019 Year End Adjustments

Due to difficulties in obtaining the necessary information, 2019 had not been closed at the time of the 2019 annual meeting. Thus, after that meeting, the necessary accounting changes were made to the 2019 books and the final balance sheet has several significant differences from that shown in the Annual Report. This document is intended to describe the changes which were made.

- The Endowment Funds are treated by the investment manager as one fund. Thus, the three funds were combined. The analysis of the Endowment account for 2018 and 2019 was performed and the resulting entries were made.
- The Fixed Assets which were reflected in the 2018 audit were incorrect. Research was done to reconstruct the actual cost of the three phases of the building: the original building, the addition of the classroom and finally the Parish Hall. This resulted in a substantial increase in the value of the building, which is added to the balance sheet.
- Two capital improvement projects from 2013 and 2018 had not been included in the accounting records. Those projects were added to the Improvements account.
- The depreciation was calculated for the revised value of the building and improvements. That correction was also entered. In addition, the 2019 depreciation was added to the account.
- The Liability "State Withholding" was reported as (\$206.44). An investigation determined that incorrect tax tables had been used for several years, thus underestimating the tax liability. The actual tax filings were performed by our outside accountant and were calculated at the correct value. Thus, this account was underfunded by \$418.60 which has been corrected (Note: this correction was made in June 2020).
- In the past, Prepaid Pledges have been taken as income in the year they were received (ex. prepaid 2019 pledges were taken as income in 2018). A prepaid pledge should be a liability in the year it is received and then taken as income in the year it is intended (this will make the reported pledge income much closer to the actual pledge income). In 2019, there was \$20,500 in prepaid pledges. This is now shown as a liability on the December 2019 balance sheet and has been recorded as income in 2020.
- Due to the changes in the accounts listed above, the Undesignated Fund balance needed to be corrected. The value is simply the increase in Assets minus the increase in Liabilities.
- The "Undesignated Funds" are really a combination of Building Fund and Operating Fund. These two funds will be reported separately.

Report of the Deacon

The Rev. Kank Bristol. Don.

This is my ninth report as deacon at St. David's Church. In this year, we experienced great change due to the pandemic lock-down and economic uncertainty of the Covid-19 virus. Additionally, as a nation, we witnessed the rise of movements against the ever-present misogyny and racism in our country – all against the background of a heated national election.

As a deacon in the Diocese of New Jersey, I am, by ordination, called to report to the Bishop on the 'state of the world' outside the church. But, as you are most probably aware, our Bishop Stokes is more than aware of the current state of the world! The challenge runs deep from Diocese to parish to individual. And yet the support and recovery we seek, I believe, will run just the opposite.

At St. David's this year, we have seen volunteers step up to not just keep things going, but assist by asking, "How can we better do this?" Going online with our services was a big step, as was the support of all our many programs. Our Vestry kept things going with a positive attitude, encouraging our Stewardship and Discernment committees.

Much of my work as Deacon has been behind the scenes, supporting others as I have been able. I also have assisted with worship and offered several of the Children's Talks – online. I enjoy this ministry but feel that the children listening-in are much older than before the lock down. A new role this year, as clergy advisor to our Sunday School, has been eye-opening for me. What a terrific team we have planning and gathering our young parishioners in their mission to make them all feel included and loved. A highlight was working together during Advent to plan an outdoor Children's Christmas Eve Service. This had never been done (in recent memory) and was a success with over forty attending.

This fall, our new rector Discernment Committee asked me to comment on what I considered our 'growing edges,' i.e., how, at St. David's, are we changed over time into who we might be as followers of Christ and how do we realize that opportunity is here – now! I believe this year points to an urgency to not hold back from working with others keeping St. David's alive and the vibrant place it is. And through our sacred community, perhaps realize that there is no better time, nor greater personal need, than to accept God's promise we hear every week: be at peace, you are mine, and I love you!

Report of the Minister of Music

Dr. Brian Kalona

2020 was a year unlike any other for the St. David's music program. Services during Lent, Holy Week, and Easter typically require weeks of planning but this year we were forced to work quickly and efficiently in order to adapt to our ever-changing world. We were faced with answering the question; how can we offer music virtually while still maintaining the quality and integrity we have grown to love? The conclusion was not an easy one, nor was it a straightforward path. After experimentation with various platforms, we launched a basic online service via GoToMeeting. Although we were able to see and hear each other, the musical aspects were severely compromised. Delayed audio resulted in poor transmission of sound, making it nearly impossible to sing even the most simplistic of hymns. A new solution had to be found.

We moved services over to Zoom and immediately experienced a higher quality. The video resolution was clear, the interactive features more advanced, and the music/audio was more successful, although still not up to the level that I had hoped. We could still only broadcast one vocalist at a time in conjunction with a barely audible piano in the background. Even after purchasing some high-quality microphones the improvements were minimal at best. After further research I landed on the idea of creating a "virtual choir." The basic concept: I would spend several hours producing an instrumental track, email it to the choir, the singers would record their vocal to the track, then send it back to me to be mixed into an entire performance. Creating the final mix is a long and meticulous process including splicing and realigning each track, blending, crossfading, adjusting audio compression, setting broadcast levels etc. Thankfully I have the proper gear and software in my home studio required to produce high quality recordings. Once all the tracks are mixed, I produced a final audio file that can be shared on Sunday morning. Our choir was finally back together! Never the same as in person, but still wonderful to hear everyone's voices join together in song.

Much happier with the end audio result, I then added the additional layer of video production to the audio tracks. Again, using software from my studio, video clips were edited together to accompany the anthem or hymns during the service. It was wonderful in many instances to utilize video and pictures from members of our congregation. This gave a more personal touch to the service, and hopefully created a memorable experience that can be listened to and viewed for years to come.

In the Fall of 2020 as State restrictions began to lift, planning began for a return to in-person worship. This presented the worship planning team with a new set of challenges. In order to accommodate a live musical broadcast from the church we had to comply with important safety requirements. Singing produces far more airborne particles than speaking, therefore a Plexiglass shield needed to be created to prevent the spread. My son Harrison and I built the barrier over a few days and then brought it to church to place on top of the organ. This was a successful addition to our worship service but not the only item that was required to broadcast live music from the church. New microphones, microphone stands/shields, an audio interface, a mixing board, and a slew of cables were required to make everything function. Through trial and error, I was able to run the sound for the entire service along with playing and singing from behind the organ. We also were able to bring in guest musicians to sing from the hallway outside the organ.

Although not a perfect presentation, the music worked fairly well for our congregants at home as well as those in the sanctuary.

The in-person worship was, however, cut short in the early winter and we returned to a strictly virtual service. At this point I experimented with having not just some of the hymns sung by a virtual choir, but all of the music for the service. The live aspect is always beneficial but the quality of the music when edited and properly mixed proved to be far superior and more effective in the end.

As 2021 begins we still take things day by day and week by week. We have learned a lot through this process, and despite all the challenges I believe a lot of good has come out of it. We are as strong as ever musically at St. David's and I cannot wait until we can all meet again in person to sing our Alleluias!

Report of the Pastoral Care Associate

Ms. Kale O'Connor

Dear Parishioners of St. David's,

2020 was a year of transition and creative adjustment in how we do ministry in the church. Pastoral Care was no exception. I want to acknowledge The Reverend Don Caron, The Reverend Hank Bristol, and Brother John Baptist OFM, all of whom have contributed to nurturing the pastoral health of our congregants during this past year in ways none of us could have imagined in 2019. The spread of the COVID-19 virus impacted everything we do.

The work of visiting parishioners who are homebound and those in the hospital continued after the COVID-19 crisis erupted in March. At that time, I switched to visiting by telephone, and expanded my list to include those who live alone now that we were quarantined, whether homebound or not, and those without computers who were not able to come to Zoom services. I am grateful to our parishioners who alerted me to people they knew in these categories.

In late August, I approached Fr. Don with an idea to expand outreach to the entire parish community and started the Telephone Call Ministry in early October. Seven willing volunteer parishioners, either singly or as a couple, each call one roster page of parishioners periodically (every 2 or so months) to stay connected with our members and offer assistance if needed. An additional benefit has been an updating of contact information. I am always available for consultation and have reached out to the volunteers asking how the work is going and answering any of their questions. The initial feedback has been very positive. Our callers report that they are enriched by the experience, and most of those called are happy to hear from them. It is proving to be a real gift for our St. David's community.

My facilitation of the Women's Lunch and Learn Group was in-person until we moved to Zoom meetings in April. Instead of taking a hiatus in the summer months, we decided to keep meeting and continued through the fall as usual. New members are always welcome.

In the summer, I suggested we resume the Prayer Station following Sunday services, and it began in July with Deacon Hank and me alternating responsibilities. It is open for ½ hour after the dismissal. In August, I started a Contemplative Prayer group that meets on the 1st and 3rd Monday of each month at 7:00 PM. After Fr. Jack Zamboni, Rector of St. Francis Episcopal Church in Dunellen, worshipped at St. David's later in August and suggested our parishes open our Contemplative Prayer groups to both churches; we began joining our congregations in prayer and friendship. A serendipitous blessing!

I gave the Sunday Children's Talk and preached when my academic schedule permitted in the winter and spring and continued monthly through the summer. When services moved back into the church in September, I no longer preached to adults or children and began leading the Spiritual Communion prayer for those who participated in Sunday services on Zoom. When all worship returned to Zoom, I already had started my last unit of chaplain training and the preliminary work for Board Certification, which does not allow me time for sermon preparation.

The clergy team and I continue to be present to grieving families at the funerals/memorial services of our congregants and honor those who have died. I send condolence letters and many cards for various reasons to parishioners, and I respond to congregants who ask for my time and attention.

My ending three sentences in last year's Annual Report are as true today as they were then. I am grateful to have the opportunity to serve the people of St. David's and thank the Vestry for their confidence in me. It is a joy and privilege to participate in the life of our church. You are always on my mind and in my heart.

Organizational Reports

Report on Christian Formation - 2020

Christian formation is the lifelong process of growing in our relationship with God, self, others, and all creation. Every experience in our lives can provide us with the opportunity to express our faith; the challenge we face is recognizing these opportunities and learning ways to live a sometimes countercultural life in a secular world.

Scope of Christian Formation activities:

Primary focus is life-long learning and growth for each congregation member. This includes Sunday School; J2A; Adult Study and Discussion Groups (e.g. Book Forum, Lenten Discussion Group).

Secondary focus is recognizing the Christian Formation aspects of many of our congregation's other activities. Worship is a major contributor to Christian Formation for every congregant as well as those who volunteer to be lay readers, Eucharistic ministers, and acolytes. Similarly, outreach gives those who volunteer at RISE an opportunity to see close-up the impact on our local community of "giving" both time and goods.

2020 Activities Report:

The Covid-19 pandemic greatly impacted the activities able to occur...

Sunday school has gone Zoom for 3-year-olds thru first grade. (Nothing for higher grades initially due to Zoom overload in that age range). The Sunday school teachers organized two great family events later in the year: the drive-thru Thanksgiving and the outdoor service on Christmas Eve. Both were very well attended. Thank you very much to the Sunday School teachers and helpers, and all those who have done a tremendous job keeping our youngest congregation members engaged with St. David's during the pandemic.

Adult learning continues with:

- Wednesday evening Book Group led by Dcn. Hank on Zoom
- Thursday evening Discussion Group led by Fr. Don on Zoom
- Women's Lunch and Learn Group on Zoom
- Contemplative Prayer Group on Zoom *NEW in 2020* This last activity is joint with another church, St. Francis Dunellen, and shows the benefit of online events bringing our congregation into community with other Christian congregations.

Use of Zoom for - live-streaming during times when the church is open for live worship; and online services when the church is closed for worship is giving weekly opportunities for all congregation members to engage in the way they are most comfortable. Thank you to all of those who have enabled the audio-visual capabilities necessary to run online services and meetings.

The feedback from RISE has reinforced for us all the importance of our church's involvement in the community during the good times. Since we were already engaged and mobilized, we could help at RISE during this time of greatly increased food insecurity in our local community.

Like much else in 2020, the Stewardship campaign went virtual this year. Through videos (with the technological assistance of Todd White and Ben Hicks), we were able to see and hear Brijette and Marcus Aris, Zack Duck, Jessica Kelly, Gil Quinton, and Amy Mansue share why St. David's is important to them and how they experience God's presence in this place.

Thanks to the work of the Stewardship Committee members - Deanna Emerson, Jean Hegedus, Ben Hicks, Jessica Kelly, David Miller, and David Thomsson - a new brochure highlighted the many ministries of St. David's and the ways in which Stewardship supports those ministries. As always, Judy Henningsen provided much appreciated support.

Not unexpectedly given the challenges of the past year and the uncertain or changed circumstances that many faced, the overall number of pledges decreased by about 10% and the total amount pledged declined by 3%. On a very positive note, of those pledging, 56% increased their pledges - up significantly from 25% in past years, and we had seven new pledges.

Additionally, many parishioners contributed time and talent in ways both expected and unforeseen at the beginning of the year - participation in the discernment process, hours of planning to reopen the church building, knitting for the Seamen, staffing the food pantry, Saturday 'Sunday' school, phone calls to fellow parishioners to check-in and make sure everyone was all right. The list goes on and on.

Going forward, St. David's can be confident it has the time, talent, and treasure to carry out its mission to be God's faithful representatives in the world.



Participations & Giving Trends from the National Church Office



The voters shall be baptized, at least sixteen (16) years of age, domiciled in the Parish or adjacent thereof, of good moral character, adhering to this church and to no other religious body, regular attendants at the service of the said Parish, meaning thereby those who are more frequently present than absent unless for a good cause prevented and regular contributor to the current expenses of the Parish for six months prior to the Annual Meeting in the manner prescribed by the Vestry of said Parish. Any voters not baptized or confirmed in the Parish must have been enrolled as members of the Parish in accordance with provisions of the Canons, or must be baptized persons who have been received on their written request to the Rector or to one of the Wardens if there be no Rector; and said Rector or Wardens shall keep a list of all who have been received as voters, which list shall be open to inspection by the members of the Parish. No one shall be permitted to vote or be eligible to office in more than one Parish in this Diocese.

Section III

St. David's By-laws

Adopted March 14, 2006
